Purpose of these analyses

- To develop a screener tool that indicates risk for findings in
 - Program Governance (GOV)
 - Management Systems (SYS)
 - Fiscal Integrity (FIS)
 - School Readiness (SR)
- Tool could trigger in-depth review in any or all of the four content areas

Methodology

- Used OHSMS data from:
 - FY2012/2013
 - FY2014
- Analyses included:
 - Correlations between CM findings and total findings in a given protocol section (p < .05)
 - Correlations between CM findings and membership in "high" and "low" performance groups ($\phi \ge .26$)
- Analyses predicted to all CMs in the related protocol section (e.g., FIS analyses predicted to findings in all of the CMs in Fiscal section)
 - SR analyses predicted to set of CMs that were related to school readiness based on discussions with OHS

CMs Selected for School Readiness Outcome

- CDE1.1 & 1.2: School Readiness goals
- CDE 2.1 & 2.2: Curriculum selection and implementation
- CDE 3.1 3.5: Individualized services for children
- CDE 4.1-4.8: Quality teaching and learning

CMs Selected for School Readiness Outcome (2)

- CHS1.1 1.7: Child access to health and dental care
- CHS2.1 2.3: Child health screening and referrals
- FCE2.1 2.3: Parent-child relationships through parent education
- FCE3.1: Parents as full partners in child's education

- FCE4.1: Successful transitions into and out of EHS/HS

Summary

- 69 potential screener CMs have been identified through the KI analysis with the two data sets
 - GOV: 20 CMs
 - SYS: 20 CMs
 - FIS: 7 CMs
 - SR: 22 CMs
- Overall agreement looks sufficient
 - However, sensitivity is weaker (particularly for school readiness)

Questions

- There are some differences in the results from the two data sets.
 - QUESTION: How should we proceed in identifying the final set of HSKI CMs?
- Data sources include child files, staff files, and observations which can be time consuming to collect
 - QUESTION: Should we look at the agreement when we exclude CMs with time consuming data collection modes?
- CMs have been identified through statistical analysis without an eye toward content
 - QUESTION: Are there items to add for face validity?
